



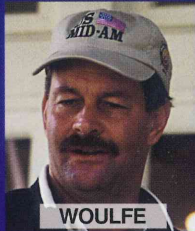

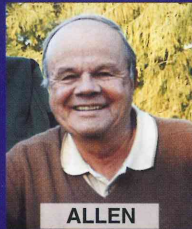

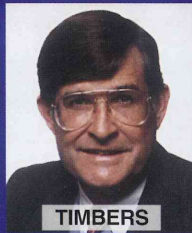

Another year, another great schedule

2001 schedule has events for players of all skill levels.

■ The 84th Florida State Amateur Championship at the highly-acclaimed **World Woods Golf Club** highlights a schedule of 21 state events conducted by the FSGA.

Events for junior golfers to senior golfers and high handicappers to low handicappers are scheduled at various sites throughout 2001.

Besides crowning the top amateur in the state at World Woods, the FSGA will hold the 46th Florida State Junior Championship at LPGA International in Daytona Beach and the 34th Florida State Senior Championship at Riverwood Golf Club in Port Charlotte. Other age division championships include the State Mid-Amateur (ages 25 and over) at **Interlachen Country Club** in Winter Park and the State Mid-Senior (ages 40 and up) at PGA Golf Club in Port St. Lucie.

Numerous four-ball events are scheduled for all age divisions. The Florida State Four-Ball Championship, which has 8 qualifiers located throughout the state, will be played on the **Blue Monster** at Doral Golf Resort in Miami.

High handicappers have some new opportunities to compete.

A new "Winter Series" was incorporated into the schedule this year. Three events - one each in February, March and April - will have both gross and net prizes. The first two events are scheduled for seniors, while the other is a Mid-Senior Four-Ball event. The popular Net Two-Man Team is still on the schedule and will be held at Mission Inn Resort in Howey-In-The-Hills.

The 60th Florida State Club Team Championship offers clubs a chance to field a team and compete against other clubs throughout the state. **Bonita Bay Club** will be the site of this annual contest.

The **Parent-Child Championship** will be returning to Disney World once again. This exciting event allows a child to play with a parent or grandparent. There is no age limit, so a 40-year-old son could play with his mom or dad.

Players are also excited about the return of the **Florida Cup Matches**. Held this year at Lago Mar Country Club in Plantation, the Matches pit 16 players from North Florida versus 16 players from South Florida in a Ryder Cup-format.

School is in session

Eight Rules of Golf Seminars and six Tournament Committee Workshops held by the FSGA this Spring.

■ There are several opportunities in 2001 for golfers to learn more about the Rules of Golf and Tournament Administration. The FSGA's Rules and Competitions Department are currently conducting eight Rules of Golf Seminars and six Tournament Committee Workshops and will conduct more this fall.

The Rules of Golf Seminars are highly interactive with situations simulated on the course. Tournament Directors from the FSGA review rulings and decisions and offer examples for discussion. The cost is \$30 with a special price of \$15 for FSGA Committee Members, High School Golf Coaches and Junior Coordinators. The seminars last from 8:30 a.m. to 4:30 p.m.

The Tournament Committee Workshops are designed to educate and familiarize FSGA Committee Members with their on-course responsibilities during the administration of an event. The workshops incorporate some indoor discussion, but the emphasis is hands-on training and observation of situations outside on the golf course. Individuals participate in sessions

involving starting, registration, scoring and on-course officiating techniques. These workshops are free of charge to FSGA Committee Members and are scheduled for 8:00 a.m. to 12:30 p.m.

Rules clinics were also held for high school golf coaches last year. Over 500 coaches attended one of thirteen clinics located throughout the state. The FSGA is proud to again assist the Florida High School Activities Association by administering more clinics later this year.

FSGA receives \$40,000 from USGA for junior program

■ We have received a \$40,000 grant from the United States Golf Association to fund the FSGA Junior Golf Program. This vital new program will serve existing and developing junior golf programs throughout the state of Florida.

During 1999 and early 2000, we identified over 50 independent junior golf programs operating in Florida. Through a series of conferences and meetings, it was determined that the greatest need of these junior programs was information on how to improve their programs and how to increase the involvement and financial support of their communities.

“This grant now allows the Florida State Golf Association to provide the assistance programs have been requesting,” said **Jim Demick**, the FSGA’s Executive Director. “Junior golfers, in turn, will have a better opportunity to learn and enjoy this great game.”

The FSGA has hired **Andrew Crabtree** as the Manager of Junior Golf. He will travel across the state visiting with the programs to assist in recruitment of both participants and volunteers and also aid in obtaining financial self-sufficiency. Efforts will also be made to gather information and make the FSGA a statewide clearinghouse for junior golf information. This should reduce conflicts and prevent new programs from “reinventing the wheel.”

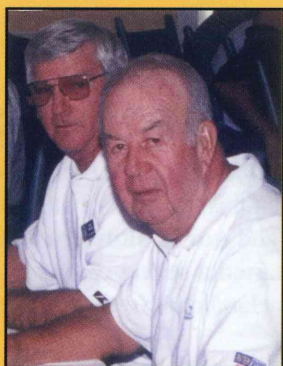
Andrew is already looking forward to the **2001 FSGA Junior Golf Conference**, which will be held April 28 in central Florida. ☺

Fifty attend Course Rating Seminar

■ Celebration Golf Club welcomed fifty of the state’s course raters for the USGA/FSGA Course Rating Seminar on January 8. **Jim Dodd** and



Scott Hovde of the USGA presented the Course Rating System and covered every step of the rating process during the morning session. The evening session moved onto the course where raters put their knowledge of the Rating System to use.

Although the rating process is systematic, the seminar provided

new raters the opportunity to slowly cover the obstacles that affect a course’s rating. Veteran raters received a refresher course and then were able to rate a couple of holes for calibration purposes.

Course raters in Florida are the busiest in the country with over 300 course ratings provided to clubs each year. For comparison, there are 32 states that do not even have 300 courses. ☺

2001 State Am at World Woods

■ In its 84th year, the Florida State Amateur Championship has become one of the most anticipated events in the state. And this year, more players than ever will be able to compete. The championship field for the State Amateur has been raised from 105 to 168 this year. This is possible because we will use two golf courses for the first two rounds of the championship.

World Woods Golf Club in Brooksville (north of Tampa) has two of the top golf courses in the state. The Pine Barrens Course is tight with pine trees and waste areas that remind golfers of Pine Valley. With live oaks, dogwoods and magnolias lining the fairway, the Rolling Oaks Course has beauty to go with its tough conditions.

Players will have 13 qualifying sites located throughout the state to choose from this year. Players advance straight from the qualifier to the championship, which will be held on June 21-24.

The State Amateur is open to Florida residents who have a Handicap Index no higher than 11.4. The entry fee is just \$85.

Entries close on May 2. Entries forms for the State Amateur and all other championships can be found on the FSGA web site at www.fsga.org. ☺

Club Team: Get your team together

■ On May 5-6, the Florida State Club Team Championship will be held at the Bonita Bay Club in Bonita Springs. Five-man teams will represent their club in this prestigious event held since 1941.

The championship is open to teams from traditional golf clubs. All five players have to be from the same club, and they also have to be members of the FSGA.

The championship covers 36 holes of stroke play over two days. Players will play both the Bay Island and Creekside courses at Bonita Bay. Similar to a collegiate event, the scores are accumulated by taking the four lowest scores of the team each round.

The cost of the events is \$750 per team (or \$150 per person) with entries closing on April 11. Each club can send as many teams as it prefers. Prior to March 28, only two teams per club will be entered into the field (in order of receipt). If the field is not full as of March 28, additional teams will be added on a first-come, first-serve basis.

Don't wait until the last minute to get your team together. Plan ahead so you can submit your entry before the championship is full. ☺

The Senior Individual is February 26-27 in Tampa at Hunter's Green and Heritage Isles. Entries close February 14. The Senior Four-Ball is March 19-20 at Magnolia Plantation Country Club in Lake Mary. Entries for this event close on February 28. The final "Winter Series" event is the Mid-Senior Four-Ball at El Diablo Golf and Country Club in Citrus Springs on April 2-3. Entries close on March 14.

The "Winter Series" is a great opportunity to invite players that may not normally compete in FSGA events. It may be because their handicap is usually too high or they head north for the summer. Whatever their reason, they now have a great chance. ☺

Florida Cup is special event



North Florida dominated the 1999 Florida Cup Matches with a 20-12 win.

■ The Florida Cup Matches is a special invitational event at the end of the year. The state's top players are invited to participate, and they compete in a Ryder Cup-format with North Florida versus South Florida. The South Florida team will have home course advantage with Lago Mar Country Club in Plantation hosting this year's event.

Players are selected using a combination of the FSGA Point's List and two captain's choices for each team. Thirty-two players are invited with 16 to a team. The players to the left are currently ranked according to their 2000 point totals, but the list could change dramatically after each 2001 event. The Point's List covers two years, but the points earned in 2001 are worth 150%.

Another special event scheduled for this year is the USGA State Team Championship. Three players will be selected to represent Florida in this national championship at Hazeltine National Golf Club in Chaska, Minnesota. Played on September 23-25, the State Team has a team of top players from every state in the country competing.

So this is your chance. The FSGA Point's List is listed in *The Member's Guide*, so look at the events in which you can earn points. With top finishes, you can quickly move up the rankings and be a part of a select group. 🏆

Rules of Golf vs. Handicapping

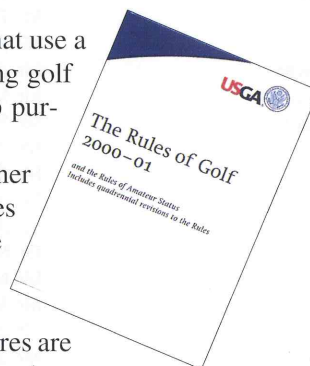
■ If you break the Rules of Golf, do you still post the score for handicap purposes? The answer is: It depends on which rule you break.

The most recent questions have come from players that use a non-conforming golf club. If you use a non-conforming golf club or ball, you cannot post your scores for handicap purposes. This is a long-standing policy by the USGA.

You will receive a different answer for many of the other rules violations. The use of preferred lies or winter rules is not endorsed but scores made while doing this can be posted. Scores can also be posted for conceded putts and mulligans. Due to their frequency, the system did not want to eliminate rounds where 17 holes of valid scores are thrown out just because one hole was played outside the rules.

Electronic measuring devices are contrary to the rules, but scores made while using these devices can also be posted.

The best answer is to always play by the rules of the game. You then know that all scores are able to be posted. 🏆
